# “Parenting Youth with Stressed Attachment”

## An Interactive Case Consultation in Four Locations

Do you have challenging children, adopted, foster or kinship? Are you a therapist working with families who face the challenges of parenting children with trauma history and attachment resistance?

Audience members at each site (you!) will bring their questions and concerns to the discussion. Each site is connected via audio visual technology. Participants at each site will offer questions to the therapist at their site and that therapist as well as those at the other three sites will offer their insights. Practical, useful strategies will be offered that work with children with stressed attachment, returning the ‘fun’ to family function!
