•The J. Stanley and Doris Hill Legacy Award will be given to a person who has demonstrated characteristics similar to those of Stan and Doris Hill. The award will be based on a person's true sense of community service. Remembering that the Hills were extremely active in our communities, this person would mirror that quality.

GENERAL CRITERIA

- The award will be community service based.
- The recipient should have given a lifetime of service to his or her community.
- The recipient should reside within our communities, but he or she serves the greater community, as well as our local area.
- The recipient needs to demonstrate outreach beyond our borders, but is required to also remain "connected" to our geographical area.

VOLUNTEER INVOLVEMENT

The award recipient will demonstrate

- ...A commitment to the community
- ...Staying engaged in the community
- ...Working on improvement of the community through involvement in service
- ...Improving the community through a genuine concern for the betterment of the community

GEOGRAPHICAL AREAS TO BE CONSIDERED

The award recipient will live within the school district boundaries of White Bear Lake or Mahtomedi. These two geographic areas, encompassing several communities, are served by the Century College Foundation, the Mahtomedi Area Educational Foundation and the White Bear Lake Area Educational Foundation.

Nominations not postmarked or received by a board member or an employee/representative of any of the three sponsoring foundations by Friday, February 27, 2009 cannot be accepted. All support materials must be no larger than 8.5" x 11." Please do not submit CDs, tapes, display materials, scrapbooks, etc.

Once nominations are received, a nominating committee consisting of two representatives from each of the three sponsoring foundations (Century College Foundation, Mahtomedi Area Educational Foundation and White Bear Lake Area Educational Foundation) will read and review all nominations to determine an award recipient.

The 2009 J. Stanley and Doris Hill Legacy Award recipient will be announced in March of 2009.

EXPECTATIONS OF AWARD RECIPIENT
