



## Century College PSEO Application and Registration Optional Check List

1. \_\_\_\_ I have met with my high school counselor and after discussing both the benefits and drawbacks of the PSEO program, we feel that the PSEO program is a good fit for me.
  
2. \_\_\_\_ I have determined that I meet college-level Reading requirements via the ACCUPLACER Course Placement Test or the ACT. I am aware that in order to take math classes, I must also test into college level math. I have a copy of my ACCUPLACER or ACT test results which I'll submit with my PSEO application.
  
3. \_\_\_\_ I meet one of the following for **Option A**: ranking requirement (juniors need to be in the top 33%, seniors top 50% of their high school class), the decile requirement (juniors need to be in the 3<sup>rd</sup> decile or higher, seniors in the 5<sup>th</sup> decile or higher) or the GPA requirement (juniors must have a 3.0 GPA or higher, seniors must have a 2.5 GPA or higher).  
**OR**  
\_\_\_\_ I meet **Option B**: the nationally standardized norm referenced test requirement (juniors-at or above the 70<sup>th</sup> percentile; seniors at or above the 50<sup>th</sup> percentile).  
**OR**  
\_\_\_\_ I do not meet the ranking requirement or the standardized test requirement, but have met with my high school counselor and still feel I may be a good candidate for PSEO. I have chosen to meet **Option C**: a letter of recommendation from my high school counselor or high school teacher & a written essay as defined in the PSEO application. I understand that I am not guaranteed admission into the program and have made alternate arrangements.
  
4. \_\_\_\_ I have completed page four of the PSEO application.
  
5. \_\_\_\_ I have met with my high school counselor and we have completed the Post Secondary Enrollment Options Program Notice of Student Registration form. I have also had a parent/guardian sign the form if I am under 18 years old.
  
7. \_\_\_\_ I have submitted page 4 of the PSEO application form, the PSEO Program Notice of Student Registration, my ACCUPLACER and/or Act test results, and any other documentation needed as outlined in Step 2 of the PSEO application before the final deadline. I am aware that all of the necessary forms must be **submitted together** and that it is my responsibility to ensure that **ALL** required materials are submitted before the final deadline.
  
8. \_\_\_\_ I have received my letter of acceptance and have signed up for my PSEO New Student Orientation Session. I understand that Century's classes fill on a first come, first served basis and that some classes may be full before I am able to register.
  
9. \_\_\_\_ I have met with my high school counselor and we have discussed which classes I should register for in order to meet any high school graduation requirements I may have left to fulfill.
  
10. \_\_\_\_ I have attended my New Student Orientation session, registered for classes, and submitted a copy of my schedule to the Advising, Counseling, & Career Center.
