Currently, resident and non-resident students have the same tuition rate. Century College students may be eligible for Minnesota residency status for purposes of receiving state specific financial aid if they meet criteria as defined below. These criteria are established by the Minnesota State Legislature and the Minnesota State system, of which Century College is a part. Students are required to prove that they have met the conditions to be classified as a Minnesota resident. **Students must prove they had a domicile (a fixed, permanent living place) in Minnesota 12 months prior to submitting this petition.** They may also be required to satisfy other conditions. A person may have only one domicile at a time.

If you wish to be reclassified for specific Minnesota financial aid, you must submit this petition to the Financial Aid Office. Regardless of the outcome of the petition, students are responsible for paying all debts owed to Century College. Petitions will be reviewed by the Financial Aid Office within 10 days of being received. Questions should be directed to the Financial Aid Office, (651) 779-3305.

Initial Here -9/11 GI Bill, Montgomery GI Bill, or Marine Gunnery Sergeant John David Fry Scholarship (or spouse / dependent of such person).

If this applies to you: Attach a copy of your DD-214, or your orders if you are active duty. Spouses must also submit a marriage certificate and dependents must submit proof of dependency with a copy of MN tax return.

Data Privacy Notice:

The college is asking you to provide information that includes private and/or confidential information under state and federal law.
