Reduced Course Load Form

This form is used for an F-1 International Student having specified initial academic difficulties, an illness or medical condition, or needing fewer credits than a full course load in their final term to complete the program of study.

Federal regulations require F-1 international students to enroll in and complete a full-time course of study during each Fall and Spring semester. Full-time study is defined as twelve (12) credit hours. Students are **required to receive approval from a Designated School Official (DSO) before dropping/withdrawing below** the number of credits required to maintain status.

Authorization to drop below a full course load for academic difficulty can only be granted for the reasons below. Only an academic advisor can sign this form. Only one reduction in course load may be authorized for academic difficulty during the entire program of study (Associate, Bachelor's, Master's). Supporting letter from academic advisor must be submitted with this form. Academic advisor signature is required.						
Student has been advised to withdraw from a course due to improper course-level placement due to college error. Student must maintain a minimum of a six-credit course load. (Letter from academic advisor is required.)						
Student is in the first academic semester and is unfamiliar with American teaching methods. Student must maintain a minimum of a six-credit course load. (Letter from academic advisor is required.)						
Student is in the first academic semester and shows difficulty with the English language or reading requirements. Student must maintain a minimum of a six-credit course load. (Letter from academic advisor is required.)						
To Complete Course of Study in Current Term:						
Student is in their final term and fewer than 12 credits are needed for degree completion. Student must be enrolled in at least one major/program required class during their final term. (DARS showing degree completion with inprogress courses used is required.) Academic advisor signature is required.
