## APPEAL INFORMATION AND PROCEDURES:

Students have the right to appeal transfer credit evaluation decisions. Refer to "Your Rights as a Transfer Student" in the college catalog. To appeal a transfer credit evaluation, complete and submit this form along with supporting documentation to the DARS/Transfer Services Office. Note: To request course substitutions or waivers complete an Academic Petition <u>not</u> an Appeal.

- 1. Meet with a counselor to review and discuss the results of the transfer credit evaluation. If an error was made, a revised evaluation will be issued in the mail.
- 2. Students are responsible for providing Century College supplemental information and/or documentation related to the evaluation of a course(s) transferring from other institutions.
- 3. Students will be notified of the results of their appeal within approximately three weeks of submitting an appeal. Students may petition the decision. Meet with a counselor to complete and submit an Academic Petition to the Vice President of Academic Affairs. A transfer decision may be appealed through the Minnesota State Colleges and Universities Senior Vice Chancellor of Academic and Student Affairs (Procedure 3.21.1).
